# BUILDING ON THE TRAIL


Over the course of the last year the Trail Maintenance Committee, as part of the Trail Assessment Program of the Appalachian Trail Conference, has been reviewing the facilities along SATC's section of the trail on Peters Mountain. The Committee has concluded that it is time to undertake improvements to the facilities at the Peters Mountain Shelter Area. It is time to build a privy and a second shelter.

Presently, there is no privy in the shelter area. During the hiking season, unhealthy and unsightly reminders of that accumulate in the woods and brush. The new privy will be of the self-composting type.

The existing shelter accomodates only four people, at best. More space is needed to accomodate hikers. In addition, the Zeager Shelter, two miles to the south, is nearing the end of its useful life. It is the source of frequent problems due to its closeness to Route 225. It will eventually be torn down.

These are major projects and will be built in succeeding years. The privy will be built in 1993 and the shelter is planned for 1994.

These will be major undertakings for the club. They will require the participation and support of many people. In addition to the volunteer labor to build them, the privy and the shelter will each cost about \$1,500 to build. While the club has some resources set aside för major projects, we would welcome contributions to help defray the costs of the materials for the privy and shelter. "THE CUMBERLAND VALLEY" - PART 2

The entire section from Clark's Ferry to Pine Grove Furnace was assigned to the Mountain Club of Maryland, headquarted in Baltimore.

When I-81 was put through, it cut through the Iron Stone Ridge. At that point, instead of pursuing the interruption of the Trail, the Mountain Club of Maryland placidly rerouted back to roads.

But, now, with the National Park Service becoming interested in taking over and protecting the entire length of the Appalachian Trail, this routing over the roads became a problem. Property owners along the route through the Cumberland Valley were able to claim "That historically, the Appalachian Trail crossed the Cumberland Valley on roads."

To make matters worse, instead of permitting the National Park Service to handle the matter diplomatically, MCM violated private property to survey out a preferred trail route. This only served to arouse the property owners in an already bad situation.

With this aggravated situation, a national organization, that was opposed to the National Park System, had come in to help organize the local citizenry against relocating the Trail. This

group was known as C.A.N.T. [Citizens Against the New Trail.] And they were turning it into a political issue, involving Congressmen Goodling and Shuster. Further, the national organization had so inflamed the local citizens that the situation promised to get real nasty. If fact, if we planned to hike the roads as a Trail Organization, we found it necessary to provide guards for our parked cars.

At this point, the Keystone Trails Association had scheduled a Board Meeting at the Youth Hostel at Pine Grove Furnace. About the middle of the previous week to the scheduled meeting, we received a call from Mac White, at Lehigh University, asking that we meet with him during that Board Meeting. Both Mac White and Thurston Griggs showed up, meeting with Anna and myself.

Mac and Thurston explained the situation, and, in light of our work with "Save The Trail," they inquired if there was anything that we could do to quiet the situation. Thurston stated, that in light of the hostility of the local citizens, that his Club would be willing to yield control of the Trail across the Valley. And, eventually this is what happened.

We agreed to try, but would need some help. A coalition seemed to be the best way to go.

With this situation, we came back to this Club, and they helped to organize a Group in opposition to C.A.N.T. The Club Officers help us organize a non-profit group, and incorporate it, choosing to call it PRO-TRAIL [Pennsylvanians Rallied On Trail Route Advocating Improved Location.] Jim Oxley deserves credit for coming up with this acronym.

The officers of this organization were: Carol Witzeman, Chairperson, Warren Hoffman, Vice Chair, and your correspondent as Secretary-Treasurer. And, we tried to keep our efforts low-key.

PRO-TRAIL eventually evolved into the Cumberland Valley Management Organization.



The "trails" in these game lands offer an infinite variety of hikes, by combining old farm roads and lanes, dirt roads and moderate "bushwhacking" over gently rolling hills and fields. We, generally, park at the Game Commission Parking Lot on Cabin Hollow Rd, about a mile outside Franklintown. We are showing several alternatives, with the longest going 7-8 miles.

From the rear of the parking lot, walk a short distance and drop down to an old farm road. This winds around and comes to a maintained road in .58 m; Turn right and follow this road to another parking area on the left in .84 m. Turn left, following a line of trees until you reach the Franklin Church Cemetary, dropping down to another parking lot in 1.37 m. Turn left and follow dirt road to an old farm lane on right, 2.16 m. The old farm lane cuts back about 1450. Follow it up hill to an open field, bearing left and following another old farm lane down to another road, 3.29 m. Turn left on this road to an intersection with another road, 3.63 m. Turn right and follow this road to another intersection, 4.84 m; Turn left and reach pipeline, 5.03 m; Follow the pipeline until you reach a dirt road, 6.05 m; turn right to next intersection, 6.34 m; then left, reaching another parking lot, 6.53 m. Shortly after the parking lot, turn right into field and follow crude trail thru field, eventually reaching the farm road we started on 7.61 m; and back to our parking lot in 7.79 m.

The hike can be shortened by using the alternative, which we have shown, and which is about 1.16 m long. This can reduce the length of the hike to about 3.9 miles by using the alternative to loop back.

Or by using the alternate trail in lieu of the route to the Cemetary, the trip can be shortened to 7.37 m.
